Frequently Asked Questions:

Q. How do I schedule a pick up service from Enterprise®?

A. You can book through www.enterprise.com , by calling 1-800-Rent-a-Car, or by calling the branch directly.

Q. What is the discount?

A. Enterprise has one set rate system for the St. Louis Metro area and flexible discounts outside the St. Louis area. National One Rate System is a set for the different regions.

Q. What is the refueling policy?

A. We have a very simple refueling policy: Bring back the vehicle with the same amount of fuel as when the rental originated. If the fuel is short of the originating amount, there will be a fuel charge above the market value to replace the fuel. This varies by market since fuel prices vary by city and states.

Q. May I use the discount for my own personal use?

A. Yes you may use the discounts for personal use as well as business. Use the same codes

Q. What are the benefits of Enterprise Plus?

A. Faster reservations, Faster rentals, “Email Extras” such as upgrades and promotional discounts

Q. What is age restriction for business or personal travel?

A. Enterprise® requires all drivers to be 21 years or older.

Q. What is required when obtaining the car?

A. A valid driver’s license and credit card. When traveling outside of St. Louis or using the car for personal use, please contact the local branch should you have questions regarding debit cards, credit cards or cash rental procedures.

Q. Is there a no-show charge if a reservation is made but not used?

A. No. We do recommend that you call the office and let them know so they can help manage the fleet.

Q. Are one-way rentals allowed?

A. Yes, through the National brand, One-way service is available. Rates vary based on what type vehicle and where the rental is being picked up and returned. National one way terms and conditions apply

Q. What is the claim process if an employee has an accident with a rental vehicle?

A. Please contact the local office where you rented the vehicle and they will fill out an accident report. Should you need roadside assistance, please contact 800-Rent-A-Car. If it the car is being used for personal use please contact your insurance company.
